(ITEM MM4/23) POTENTIAL DELAY OF SYDNEY METRO WEST PROJECT

Summary

I write this Mayoral Minute with deep frustration and concern in response to recent media reports, which suggest that the Minns Government is contemplating delaying the Sydney Metro West Project.

Only two months ago, I put forward a Mayoral Minute on this very issue, and as feared, reports are emerging that this vital piece of community infrastructure is now at risk. This critical initiative includes the long-awaited construction of the Burwood North Metro Station, poised to bring immense benefits to our community. Significant work, planning, and investment have already been dedicated to this landmark project, and any potential delay in its construction would be nothing short of an unacceptable outcome.

The Burwood Railway Station has been at capacity for years now, and alone can no longer meet the needs of our residents and visitors. Our community has placed its trust in the NSW Government, expecting that they would honour their commitment to the delivery of this crucial project.

I have already taken the initiative to write to the Premier, urgently flagging these concerns and stressing the importance of honouring the commitment made to our community. We, as the representatives of this community, must stand united in demanding that the NSW Government exhaust every possible course of action to ensure the timely delivery of this project, as promised.

The Burwood After Dark Strategy (the strategy) sets a long-term vision and a cohesive roadmap for Burwood's night-time economy. Focused on Burwood (referring to Burwood Town Centre and Burwood North area), this Strategy seeks to make the area a more vibrant place with a diverse range of cultural activities, events and entertainment after dark.

This strategy has been informed by the preparation of the Burwood Economic Development Discussion Paper, and extensive community consultation with local residents, businesses and key private and government stakeholders. The implementation of a vibrant, diverse and safe night-time economy in Burwood is contingent on a successful After Dark Strategy. This Strategy explores how this vision can be achieved through four focus areas – Place, Connection, Experience and Destination.
