- If there are no pecuniary interests or other matters of the kind required to be dis closed under a heading in this form, the word "NIL" is to be placed in an appropriate space under that heading.

IMPORTANT INFORMATION

This information is being collected for the purpose of complying with clause 4.21 of the Model Code of Conduct.

You must not lodge a return that you know or ought reasonably to know is false or misleading in a material particular (see clause 4.23 of the Model Code of Conduct). Complaints about breaches of these requirements are to be referred to the Office of Local Government and may result in disciplinary action by the council, the Chief Executive of the Office of Local Government or the NSW Civil and Administrative Tribunal.

The information collected on this form will be kept by the general manager in a register of returns. The general manager is required to table all returns at a council meeting.

Information contained in returns made and lodged under clause 4.21 is to be made publicly available in accordance with the requirements of the Government Information (Public Access) Act 2009, the Government Information (Public Access) Regulation 2009 and any guidelines issued by the Information Commissioner.

You have an obligation to keep the information contained in this return up to date. If you become aware of a new interest that must be disclosed in this return, or an interest that you have previously failed to disclose, you must submit an updated return within three months of becoming aware of the previously undisclosed interest.

J. DISCRETIONARY DISCLOSURES

1. My former husband, Christopher Carolan, is a consultant to Grocon Pty Ltd. Grocon holds options along the northern side of Parramatta Road corridor at Concord, near Concord Oval. These options are in the immediate vicinity of what I understand to be the location of Burwood North Metro station, created by Sydney Metro, and consists of 14 lots and 32 dwellings and may be developed for a 'Build to Rent' project.

I make this discretionary disclosure as:

- i) although the site sits in City of Canada Bay local government area, the proximity and scale of these properties is close to the proposed Burwood North Metro station and Burwood Local Government boundaries; and
- ii) a pedestrian access point to Burwood North Metro is planned for Burwood Road, corner of Parramatta Road and Esher Lane, and this access point is situated within Burwood LGA boundaries.
- 2. My workplace, the Health Services Union, has endorsed and supports Lend Lease Corporation's concept to develop key-worker housing, targeting health care workers, above the Burwood North Metro station which is under construction at Concord.
- 3. My workplace, the Health Services Union, has joined Housing Now! an alliance of industry bodies, unions and housing advocates working together to tackle the housing crisis and provide key-worker housing in Sydney, and has contributed funds to its media campaign which will target councils and candidates in the lead up to Local Government elections in September 2024.
- 4. My workplace, the Health Services Union, supports Third.i in their efforts to develop affordable housing, particularly for Health and Aged-Care workers in Sydney.
- 5. I am a social member of the following clubs: Club Canada Bay, Club Five Dock, Drummoyne Sailing Club and Wests Ashfield Leagues Club.
