
This Half-Yearly Report is the final report for the Operational Plan Financial Year 2023/2024.

It provides the community with a summary of how Council has responded in the second half of the 2023/2024 financial year to the strategic goals, objectives and planned actions in the Delivery Program 2022 to 2026.

## Collaborating with our Young People


Following extensive youth led engagement, the four-year Youth Action Plan was adopted by Council in February 2024.

#### Celebrating our Diverse Community

In April 2024, Council adopted the Multicultural Burwood Strategy 2024–2028 that was developed following consultation with the CALD Communities Forum. Year One actions are underway including the formation of the Burwood Strathfield Multicultural Forum comprising of 40 community organisations across the region.

Additionally, in March 2024, Council delivered a Harmony Day event in Burwood Park with 20 culturally diverse community groups and the Multicultural Advisory Committee.



#### Welcoming Burwood's Newest Citizens

Two citizenship ceremonies were held between January and June 2024.

The Australia Day Citizenship Ceremony saw 89 new citizens welcomed to Burwood and a further nine citizens welcomed in March 2024.



## Our Commitment to Reconciliation

The development of Council's Reconciliation Action Plan (RAP) has now commenced with the establishment of an internal RAP working group and the engagement of First Nations consultants, Yarnup.

Community engagement with First Nations elders and key stakeholders is underway.



#### **Supporting the Community Sector**

In June 2024, a total of \$55,000 was awarded to 12 organisations to deliver new community projects under Council's Community Grants Program with a presentation held to acknowledge successful applicants and their projects.

Additionally, Council promoted the Club Grants funding program again this year.

#### The Success of the Burwood Art Prize Continues

The Burwood Art Prize was held in June 2024 and showcased some of Sydney's best emerging and established artists with nearly 300 entries received.

The Burwood Art Prize displayed its largest pool of finalists to date with 96 artworks installed in the Burwood Library and Community Hub for the community to enjoy.

#### **Burwood Citizen of the Year Awards**

In conjunction with the Australia Day citizenship ceremony, the Citizen of the Year Awards were held in January 2024.

Eight nominations were received across four categories including two new categories and the winners were:

- Young Citizen of the Year (aged 16 to 25): Rose Palmer
- Sportsperson of the Year: Danny Silvestri
- Environmental Citizen of the Year: Billie Ayling

The recipients will continue to be invited to participate and represent the Burwood community at various events and initiatives throughout 2024.



#### **Celebrating our Invaluable Volunteers**

National Volunteer Week occurred in May 2024 where Council celebrated the wonderful work of our volunteers through the Volunteer Recognition Awards.

The ceremony celebrated the outstanding work of our volunteers including 21 nominations with 80 people attending on the day.



#### Ongoing Usage of Facilities and Parks and Open Spaces

Our facilities and parks and open spaces continue to be well utilised by our community with total booking numbers as follow:

- 2,574 uses of community facilities such as the Community Hub and Woodstock
- 1,617 uses of parks and open spaces such as Henley Park and Flockhart Park
- Woodstock Artisan market held in February 2024

The success of Council's community facilities and parks and open spaces was further highlighted through the results of a survey which identified that:

- 85% of users are satisfied with the booking process
- 100% of users are satisfied with accessibility

#### **Keeping Burwood Safe**

Council's ongoing efforts to contribute to the safety of Burwood included:

- Commencement of the implementation of the Safer Burwood Plan including the successful Community Safety Expo held in Burwood Park in March 2024
- Working with community support services including the Police to establish a Domestic Violence Hub for women and families in the Burwood Library and Community Hub
- 95% of actions in Council's Child Safe Plan have been implemented

#### Mobile Play Van zooms!

An estimated 2,300 families attended the mobile play van during the reporting period with recent Service Participants Survey results showing a 95% satisfaction rate for both quality of staff and the service.

In addition to the 'play' component of the service, the staff have also introduced a number of other activities to support our community including:

- Regular service support visits from Centrelink;
- The employment of a Chinese speaking support worker once per month; and
- Facilitation of engagement on key projects such as the Burwood North Masterplan.

#### Enfield Aquatic Centre (EAC) – a much loved community asset

The success of the EAC continued reaching key milestones such as:

- The goal of 100,000 visitors during 2023/2024 was surpassed with a total of 152,710 visitors attending the Centre
- The Royal Life Saving Aquatic Facility Safety Assessment Audit was completed in February with the EAC exceeding its targets and achieving a safety score of 92% and a 5-star accreditation score of 91%
- Our learn-to-swim program remained strong and the success of our recruitment and training initiatives resulted in 16 new staff being on-boarded to the Learn to Swim team
- Eight health, fitness and wellbeing programs were delivered boosting visitation
- New initiatives were introduced including the 'Cool Down in January' initiative

#### **Our Public Art Program**

The delivery of our public art program continued with both temporary and permanent commissions, including:

- Light a Lantern Installation across Burwood Pond
- Wilay Mulaa: Spirit of Light in Burwood Park
- ANZAC Day crosses installation in Burwood Park
- Back in Black: AC/DC Mural
- 'People of Burwood' installation across public bench seats

New banner artworks were also commissioned including the 150 Years of Burwood banners.





#### Delivering Events for our Community

During the reporting period, Council's commitment to the delivery of community and civic events continued with:

- ANZAC Day Tribute
- National Servicemen's Memorial Service
- Lunar New Year
- Harmony Day
- Seniors Festival
- An expanded Community Safety Expo
- New events celebrating 150 Years of Burwood including 'Light a Lantern' and the official opening of the Burwood Park Pond, Nature Play and Sensory Garden, the launch of Wilay Mulaa: Spirit of Light and the highly successful Burwood Street Party, which attracted over 20,000 attendees







#### Using Technology to Improve Service Delivery

During the reporting period, Council implemented a range of technology tools to enhance service delivery to our community including:

- The first phase of the new Enterprise Resource Planning (ERP) system was successfully implemented
- 100 sensors were installed in public waste bins across the Burwood LGA to optimise waste collection
- A new process manager platform was implemented to ensure Council captures and streamlines complex business processes to improve efficiencies and effectiveness
- A new Human Resource Information System (HRIS) was implemented to improve and streamline all stages of the employee lifecycle

In addition to the above, Council has created an internal Artificial Intelligence (AI) Working Group to explore other smart technology applications.



## Planning for the Future of the Burwood LGA

The excitement of planning for the Burwood LGA's future continued with the Burwood North Precinct Masterplan being endorsed by Council in May 2024.

The Masterplan establishes the Vision for the Precinct and is a significant milestone resulting from two years of intensive strategy work and extensive community engagement.



#### The New Home for Arts and Culture in Burwood

The Urban Park, Arts & Cultural Centre is in full swing with 70% of detailed design having been completed by June 2024 and construction due to commence in the first half of 2025 subject to the Burwood Place development program.

This exciting project will transform the existing carpark in front of the Burwood Library into a vibrant hub, supporting the transformation of Burwood as a cultural and events destination.






#### **Creating Places for People**

Council's commitment to creating great places for people continued during the reporting period with key activities being implemented including:

- Council finalised Burwood's inaugural Placemaking Framework and formed the Burwood Place Management Committee in June 2024.
- In June 2024, Council secured \$150,000 in funding to deliver Burwood Culture Streets as part of the State Government's Open Streets Program.
- Keith Smith Park Transformation Council's ongoing asset upgrade program saw Keith Smith Park in Croydon receive a facelift with a new playground, a new footpath and new accessible seating, bubbler, bin and signage.
- Council successfully secured \$650,000
  of grant funding through the NSW
  Government Infrastructure Grants
  to upgrade Flockhart Park which will
  see a new inclusive playground, water
  bubblers, fitness equipment and a new
  shade structure installed
- Council's partnership with Burwood Chinatown has successfully implemented the fortnightly closure of Clarendon Place to cars, creating an active pedestrian space for people with the program being extended into 2024–25.

#### A Green and Sustainable Burwood

- Council planted an additional 164 trees in parks and 3,393sqm of ground cover as a result of successfully attaining grant funding from Local Government NSW
- Street tree and park tree inventories have now been completed as a result of successful grant funding with the inventory being placed in Council's asset management system to assist with successfully maintaining this important asset
- The Food Organics and Garden Organics (FOGO) trial was extended for a further six months aiming to divert organic waste from landfill



#### **Reaching our Community**

Council continues to increase our reach with the community via various communication channels with increases in the following areas:

- 10% increase in the open rate of the weekly Community Council updates, special communications from the Mayor of Burwood and business e-newsletters
- 50% increase in Facebook reach and a 5.3% increase in followers
- 36.1% increase in Instagram followers
- 19.8% increase in LinkedIn followers
- 73.4% increase in WeChat followers

Additionally, 137 projects were exhibited on Participate Burwood with 34,347 views by 15,868 visitors.

#### Our Commitment to Customer Experience

Council's commitment to continually enhancing our customer experience continued with:

- The adoption of the inaugural Customer Experience Strategy 2024–2027 which was recognised as a 'Finalist' at the Local Government Excellence Awards in May 2024
- 1,032 customers were served at the Customer Service counter with 81.3% served within five minutes
- 11,054 calls taken by our Customer Service team with 82.57% answered in less than 40 seconds
- 494 Webchats responded
- 33 new staff members participated in the Call Centre Experience
- An overall Customer Experience Score (CX) of 8.1 based on 6,500 rating was received
- The Mystery Shopping Program resulted in an overall score of 94% for phone calls and 96% for in-person visits
